Notice is hereby given in accordance with Massachusetts General Laws, Chapter 40A, Sections 11 and 15, that a virtual remote public hearing will be held by the Rockland Zoning Board of Appeals on Tuesday, November 4, 2025, at 7:30 p.m. application submitted by Renos & Beyond, LLC for 158 Central Street, Rockland, MA, for a Variance pursuant to Zoning Bylaw Section 415-22 (Building and Lot Requirements) Side Yard Setback Requirements: All buildings, structures and uses shall be set back no less than 15 feet from all external streets, Section 415-33 (driveway across adjoining parcel), and Section 415-89.1 (Variance). Applicant is seeking to divide off a portion of its property and create a retreat lot by an ANR Approval Process if the requested variance is approved. The property is located in the R-2 Residence Zoning District, Section 415-9 of the Zoning Bylaws, and is further identified as Lot 77, Map 55, on the Rockland Assessor's Maps. #### NOTE TO REMOTE MEETINGS

- 1) All or any of the members of the public body may choose to participate in a public meeting via remote access. Meetings may be virtual in their entirety.
- 2) The public will not be allowed into a Board/Committee meeting, even where there are any members of the public body and/or town staff or official (s) physically present at the meeting location during the meeting. "Public comment" portions of meetings will be temporarily suspended.
- 3) However, the public will be provided with alternative access through which they can watch or listen to meetings "in real time" and meeting notices will specify the manner in which members of the public may access audio or video of the meeting as it is occurring.
- 4) If, despite our best efforts, our technological capabilities do not adequately support public access to virtual or remote meetings, the Town will ensure that an audio or video recording, transcript, or other comprehensive record of the public proceedings at the meeting is posted on the Town's website as soon as possible after the meeting.
- 5) Notices for public hearings will contain additional information about how the public may participate via electronic/technological means.
- 6) For executive session meetings, public access to the meeting will be limited to the open session portion(s) of the meeting only. Public access to any audio, video, internet or web-based broadcast of the meeting will be discontinued when the public body enters executive session.
- 7) Where individuals have a right, or are required, to attend a public meeting or hearing, including executive session meetings, they will be provided with information about how to participate in the meeting/hearing remotely.
- 8) Meeting notices will still be posted at least 48 hours in advance (not counting Saturdays, Sundays, or legal holidays), unless it is an emergency as defined under the Open Meeting Law (in which event, the meeting notice will be posted with as much advanced notice as is possible in the circumstances. Minutes will be taken.
