ABINGTON & ROCKLAND JOINT BOARD OF WATER COMMISSION MEETING:

The Abington & Rockland Joint Board of Water Commission held a meeting in open session on February 15, 2023, at 4:01 PM at the Abington & Rockland Joint Water Works Office, 366 Centre Ave, Rockland, MA. Present were the following Commissioners:

Mr. Corvi motioned to approve the January 17, 2023, minutes. Mr. Cormier seconded the motion, and it was unanimously approved.

The Board reviewed the January 2023 Financial Report. Mr. Corvi motioned to accept the Financial Report. Mr. Saucier second the motion and it was unanimously approved.

Mrs. Cameron presented the Superintendents Report. She informed the Board we have obtained the ASO permit for sludge removal, a new cleaning company has been hired and scheduled to start March 1, 2023, lots of resumes have been received for the part-time position, articles were submitted and the difficulties with the Rroute18 water main repair were discussed. Mr. Cormier motioned to accept the Superintendents Report. Mrs. Dooner second the motion and it was unanimously approved.

Mr. Corvi motioned to close public form. Mrs. Dooner seconded the motion, and it was unanimously approved.

The Board acknowledged the three applicants: Bill Kressler, Adam Majenski and Amanda Gregory for Chief Operator interviews. The Board interviewed each applicant individually, asking them about their work experience, what set them apart from the other candidates and why they would be the best candidate for the job. After interviewing all three applicants, Mrs. Dooner said we are lucky to have all three. Mr. Corvi motioned for Amanda Gregory to Chief Operator. Mrs. Dooner stated she agreed with Mr. Corvi. Mr. Saucier second the motion and it was unanimously approved.
