Mr. Corvi motioned to open the meeting at 3:39 PM. Mr. Saucier seconded the motion, and it was unanimously accepted.

Mr. Corvi motioned to accept the minutes from the January 14, 2025, meeting. Mr. Saucier seconded the motion, and it was unanimously accepted

The Board set the next meeting date for April 16, 2025.

The Board reviewed the Financial Report. Mrs. Cameron stated she is watching the employee benefits line item. Mr. Corvi motioned to accept the Financial Report. Mr. Cormier second the motion and it was unanimously accepted.

- no known water leaks in the system
- the status of the shingle mill project in Rockland

Mrs. Cameron, the Board and Miss McManus discussed the water needed for the projects being proposed by Southfield Redevelopment. The Board discussed not having water for the proposed projects. Exploring finding other water sources was discussed.
