## ABINGTON & ROCKLAND JOINT BOARD OF WATER COMMISSION MEETING:

The Abington & Rockland Joint Board of Water Commission held a meeting in Open Session on May 23, 2023, at 4:04 PM at the Abington & Rockland Joint Water Works Office, 366 Centre Ave, Rockland, MA. Present were the following Commissioners:

Mrs. Cameron and the Board reviewed the proposed Water Usage Restriction Policy. The Board discussed the proposed policy, violations of restrictions, water fines and current water capacity limits at length.

After a discussion regarding the water level at the Hannigan Reservoir, Mrs. Cameron suggested the Board Implement the Step 3 water restriction. Mrs. Dooner motioned to go to the Step 4 water restriction tomorrow (5/24/2023). The Board discussed the necessity of Step 4 at this time. Mrs. Dooner rescinded her motion. After further discussion, Mrs. Dooner motioned again to go to the Step 4 water restriction. Mr. Saucier second the motion and it was voted four in favor and one opposed, Mr. Dion. Mr. Corvi asked Mrs. Cameron and Mr. Royal to finalize the Water Usage Restriction Policy and bring it back to the full Board.

The Board set the next meeting date for June 13, 2023, at 3:45 PM.

At 5:04 PM, Mr. Corvi motioned to go into executive session for the purpose of contract negotiation With the union and not to reconvene in open session. Mrs. Dooner second the motion and it was voted as follows; Mr. Corvi yes, Mr. Saucier yes, Mrs. Dooner yes, Mr. Tassinari yes, and Mr. Dion yes.
