He said the 90 day suspension the Board previously issued ends on July 1st and, with the Board's next meeting on July 8th, the suspension will remain until July 8th. Mr. Clifford said the Select Board is the appointing authority for the liquor license only; several Town inspectors have outstanding issues to be addressed. Mr. Clifford said the Banner license will
