Terms of the Application

- This is a free of charge service to incorporated Residents only (no businesses.)
- The Resident **MUST** fill out this application and sign the waiver form to register for a delivery
- Completed Application & waiver form **MUST be submitted**
- Dates of Delivery: Starting **August 5, 2023** Saturdays only 8:00 AM
- The Resident will be notified via email one business day prior to delivery (if delivery scheduled on Monday, the notice will be made on Friday)
On the day of delivery, please have any obstructions in the drop off area removed (parked vehicle, garbage cans)
- Drop off Location will be arranged **AFTER** the application is approved.
- The Application can be picked up **AND** dropped off at the Board of Health Office (242 Union Street) or it can also be downloaded on Board of Health website. <https://www.rockland-ma.gov/205/Recycling-Center>

WAIVER & RELEASE OF ALL CLAIMS FOR DELIVERY OF MULCH

In consideration of the Town of Rockland delivering the mulch to me at the Property at no cost or expense to me, I hereby agree as follows:

Acknowledgment and Assumption of Risk of Injury and Loss

I represent that I have the legal authority, and the necessary abilities, skills, and knowledge, to accept delivery of the mulch at the Property. I acknowledge that after delivery of the mulch by the Highway Dept I am solely responsible for the cleanup storing, spreading, moving, and using the mulch on the Property. I recognize and I acknowledge that the delivery of mulch at the Property involves risks of bodily injury, death, and property loss. I hereby agree to and do, assume the full risk of any injuries, including death, and of any property loss, and all expenses, costs, damages, and losses that I may sustain as a result of accepting delivery of the mulch at the Property.

Waiver of and Release of Claims

I hereby agree to, and do, waive, release and relinquish all claims, demands, rights of action, damages, liabilities, and controversies of every kind, known and unknown, present and future, that I may have against the Town and its officers, agents, servants, employees, insurers, related or affiliated individuals or entities, successors and assigns arising out of, connected with, or in any way related to my acceptance of the mulch at the Property.

Indemnity & Defense

I hereby further agree to indemnify and hold harmless and defend the Town and its officers, agents, servants, employees, insurers, related or affiliated individuals or entities, successors and assigns from any and all claims, lawsuits, demands, damages, liabilities, losses, and expenses, including attorneys' fees and administrative expenses, of every kind, known and unknown, present and future, arising out of, connected with, or in any way related to my acceptance of the mulch at the Property.
